## Boat Licence

### Note 1

The purpose of the boat licence fee is to raise money to manage and maintain the Harbour and the Creek. Boat licences entitle you to launch your boat and must be displayed on the craft. Boat licences are not an automatic entitlement to leave or park your boat. **It is a requirement that you have third party insurance before you launch.**

The Annual Fees for all moored or launched craft including sailboards are:

Overall length 8ft to 20ft £30.00 Overall length over 20ft £50.00

Boats on an authorised mooring are entitled to one free tender under 10ft length.

The Trust makes certain allowances for those who

- *were born in Burnham Overy Parish and are permanently resident in the Burnhams* OR
- *have been full-time permanent residents in the Burnham Overy Parish for the last 5 years* OR
- *are Licensed Work Boat Owners*

who may receive free, non-transferable, licences on completion and return of this form.

## Membership

### Note 2

All Members pay £5 per year. There are currently two classes of Annual Membership; Full Members and Associate Members.

Full Membership is exclusive and only open to the following;

- *those who are on the electoral roll of Burnham Overy Parish* OR
- *are ratepayers in that parish* OR
- *were born in that parish and now live in any one of the other Burnham Parishes*

**Only Full Members may vote at the AGM. Associate Membership is open to ALL those who share the Trust's aims.**
